Scottish Government planning changes

On February 23 The Scottish Government published new guidance on applications for onshore generating stations and overhead lines made under sections 36 and 37 of the Electricity Act 1989.

The Scottish Government also announced its intention to launch a consultation in the near future on fees charged for both onshore and offshore applications under sections 36 and 37. Once the consultation is launched, stakeholders will have 12 weeks to formally respond with any views. We will let members know when this consultation opens and Scottish Renewables will be responding to this consultation.

Police Scotland and abnormal loads issue

The short-term change in policy from Police Scotland to support abnormal load movements for one wind farm at a time continues to be a concern for industry but is a consequence of an unprecedented situation.

There has been a significant increase in Police Scotland's availability recently and following positive engagement with Scottish Renewables they are providing the maximum resources they can. Scottish Renewables is continuing to work closely with our affected members, RenewableUK and The Scottish Government to liaise with Police Scotland to find a solution to this issue.



Majority of Scottish voters support building more onshore wind

Polling published in February by RenewableUK, working in collaboration with Scottish Renewables, revealed that most Scottish voters support building more renewable energy projects in Scotland to tackle climate change. 74% said they would think favourably of a political party which puts a strategy in place to do this, with only 6% against. National Grid ESO update on HND and ScotWind

ESO has published its <u>proposal</u> for incorporating the outcome of ScotWind into the OTNR Holistic Network Design, with a split process to deliver some capacity by 2030 and other grid connection offers updated by Q1 2023.

Significant concerns with this proposal have been raised by some members and we are seeking greater clarification from

ESO on the detail and how developers will be further engaged in the process.

Consenting projects awarded funding from OWGP

<u>Eleven companies</u> have received Innovation Grants towards projects that could accelerate offshore wind consenting, and another <u>20 companies</u> in North East Scotland are being taken forward as part of the OREC 'Fit For Offshore Renewables' programme.

Separately, The Carbon Trust has four live tenders for projects under its <u>Integrator project</u>.

Annual Contracts for Difference

The UK Government last month announced the rollout of <u>annual CfD auctions</u> to boost renewable deployment. This will increase the frequency of the allocation rounds to every year, from around every two years as it is currently. The next allocation round, AR5, will be brought forward to March 2023 and it is the Government intention that the subsequent allocation rounds will be held every 12 months in the following years. Allocation Round 4: All potential timeline scenarios published

All potential timeline scenarios for Allocation Round 4 (AR4) are now available on the AR4 portal. National Grid ESO has now informed applicants whether they are eligible to participate in the round.

The AR4 timeline after the qualification assessment window will initially depend on whether there are any non-qualifying applicants. If there are non-qualifying applicants, the shortest possible timeline for AR4 will no longer be applicable.

Further updates on the progress of AR4 will be provided via the <u>AR4 portal</u>.

Access and Forward-looking Charges Significant Code Review (Access SCR)

Scottish Renewables held a Policy Advisory Group on February 7, 2022. The meeting focused on initial discussion about the consultation from Ofgem on the 'Access and Forward-looking Charges Significant Code Review:

Consultation on Updates to Minded to Positions and Response to June 2021 Consultation Feedback'.

TNUoS Call for Evidence - Next Steps

Ofgem published the <u>next steps on TNUoS reform</u>. We are pleased to inform you that the letter addresses many of the points that we included in our <u>consultation response</u> last year.

Volatile charges are expected to be addressed in a short-term review, which will help with the predictability and cost-reflectivity of the regime, and fundamental questions regarding the function of TNUoS in a net-zero, flexible and decentralised energy system are expected to be covered in a long-term review.

Distribution Use of System Charges: Significant Code Review launch

Ofgem published a <u>letter</u>, which confirms the decision to descope the wide-ranging review of Distribution Use of System ('DUoS') charges from the current 'Access SCR' and take it forward under a dedicated DUoS SCR.

The letter addresses many of the points from our <u>consultation</u> <u>response</u> last year. There is recognition of a need for tactical changes to ensure efficient system outcomes and support

decarbonisation, and there is commitment to ensure that stakeholder forums are genuine forums for challenging and not just one-way communication of proposals.

New Independent Report - Long Duration Electricity Storage in GB

Aurora Research published a <u>report</u> that demonstrates the potential role that Long Duration Energy Storage (LDES) could play in ensuring energy security in GB. The report outlines that up to 24GW of LDES – an eight-fold increase on the current installed capacity – could be needed to integrate wind power into a secure net-zero electricity system.

LOW-CARBON HEAT



Capital funding for heat networks announced

The Scottish Government has <u>announced</u> the establishment of its new £300 million Heat Networks Fund, replacing the LCITP, which will be open all year round to both public and private sector applicants and will provide capital funding for large-scale heat networks. The Scottish Government is shortly going to announce pre-capital support to assist with the development of a long-term pipeline for capital investment. Read our reaction on our website.

<u>Development Fund</u> which will be open to applications from

February 21 to May 30. All development work should be fully completed by October 31 with a possible extension depending on the scale of the work undertaken.

Heat in Buildings: Green Heat Finance Taskforce

The purpose of the <u>Taskforce</u> is to develop a portfolio of innovative financial solutions for building owners in Scotland to ensure that by 2045, our homes and buildings no longer contribute to climate change.

Scottish Renewables sits on the core Taskforce and, as such, would like to create a Working Group of members to feed into the Taskforce. We will send out further details on how to apply to be part of the Working Group to the Low-Carbon Heat Forum shortly.
