After a lengthy and collaborative process we have now submitted our <u>final consultation response</u> to The Scottish Government's <u>draft NPF4 consultation</u>, with both RenewableUK and Energy UK both sending letters fully endorsing SR's position.

As planning is such a key enabler of our industry and as many of the issues with the draft NPF4 are in the detail of the text, we are calling for extensive redrafting of the policies that affect renewable energy. To support this call, SR have also submitted a <u>final version proposed redrafting of the NPF4 text</u>.

Holyrood Engagement

It's been a very busy month for our advocacy at the Scottish Parliament. Ben Walker and Mark Richardson delivered our exhibition 'Renewable Energy - Delivering Scotland's clean energy revolution' in the Scottish Parliament Garden Lobby, an event which was sponsored by Jenni Minto MSP. We met with over 50 MSPs including Nicola Sturgeon, First Minister of Scotland, Lorna Slater, Minister for Green Skills, Circular Economy and Biodiversity and Anas Sarwar, Leader of Scottish Labour.

We also ran an exhibition stand at the Scottish Conservative Conference in Aberdeen where we met with 11 MSPs and MPs, including Alister Jack, Secretary of State for Scotland. Claire Mack also joined a panel event on the Future of the North Sea alongside Greg Hands, Minister of State for Business, Energy and Clean Growth, and Liam Kerr, Shadow Cabinet Secretary for Net Zero, Energy and Transport.

We have been continuing to engage with opposition spokespeople for Net Zero, Energy and Transport and held two roundtables with Colin Smyth, Scottish Labour spokesperson and Liam Kerr, Scottish Conservative spokesperson respectively.

SR Final Responses: Draft National Planning Framework 4 (NPF4)

As detailed in the introduction to this email, Scottish Renewables has submitted a <u>final consultation response</u> to The Scottish Government's <u>draft NPF4 consultation</u>, as well as a <u>proposed redrafting of the NPF4 text</u>. SR has worked collaboratively with RenewableUK and Energy UK and both have submitted letters fully endorsing SR's final consultation response.

Information on the forward timetable is available at the <u>Transforming Planning</u> webpage. Following the close of The Scottish Government's consultation on March 31 and Parliamentary scrutiny, The Scottish Government will analyse the responses and consider amendments to be made to the NPF4. An independent report analysing the responses will be published in due course. The Local Government, Housing and Planning Committee will debate NPF4 on Tuesday, April 19.

As set out in section 3CA(6) of the 1997 Act, a summary of representations received as part of the consultation will form part of an explanatory document to be laid before Parliament as part of the final adoption process for NPF4. The final adoption date, originally scheduled for Summer 2022, will depend on Parliamentary scrutiny and approval.

Consultation on Proposed Changes to Fees Charged for Applications Under the Electricity Act 1989

The Scottish Government and Energy Consents Unit <u>launched</u> a <u>consultation</u> on March 30 seeking views on proposed changes to application fees under the Electricity Act 1989 as follows:

- An increase to existing fee categories of approximately 20%
- New bandings for larger scale applications for developments that exceed capacities of 500MW, 750MW and 1GW
- Changes to the fees and bandings for variation applications to reflect the increased resource needed where these applications require an environmental impact assessment.

Scottish Renewables will be responding to this consultation, which closes on June 23.

Police Scotland and abnormal loads issue

There has been a significant increase in Police Scotland's availability recently, resulting in some improvements in delivery capability. On March 14 Scottish Renewables, in collaboration with RenewableUK, held a constructive stakeholder meeting with representatives from OEMs, hauliers, Police Scotland and The Scottish Government to discuss operational issues and next steps.

Scottish Renewables is continuing to work closely with our affected members, RenewableUK and The Scottish Government to liaise with Police Scotland to find short, medium and long-term resolutions to this issue.



Timeline reminder: Onshore Wind Policy Statement refresh

The Scottish Government advises that its goal is to have the final statement out to publication in the summer. It is aiming for August officially, but this is very much subject to change. The remainder of the process, for clarity, is as follows:

- January 31, 2022 <u>OWPS consultation</u> closed
- February April / May 2022 OWPS consultation analysis
- February June 2022 OWPS redrafting
- July 2022 Cabinet Secretary to consider
- · August 2022 OWPS Final to be published

SR's <u>consultation response</u>, submitted in January, 2022, is available on the SR website. The number of responses The Scottish Government received to the consultation may affect when the OWPS consultation analysis can be published.

New report - Storage for Constraint Management

NGESO commissioned research with DNV to study the value of storage for constraint management. The results suggest

that the application of storage technologies for constraint management is a technically viable way to reduce network overloads between now and 2030. However, if storage is contracted for constraint management on an exclusive basis it would be uneconomic.

Ofgem's Network Price Controls Open **Hearings (RIIO-ED2)**



Keith Greener Grid Park launch event

Angeles attended the Keith Greener Grid Park launch event, held by Statkraft on March 16.

This innovative technology uses rotating stabilisers to mimic the effect of coal or gas-powered turbines by providing inertia and maintaining the right frequency to ensure stability in the electricity system. The technology aims to reduce the costs of generating more renewable electricity and assist NGESO's target of being able to operate a zero-carbon electricity system.

Heat Networks Delivery Plan published

The Scottish Government published its Heat Networks Delivery Plan at the end of last month. An analysis of the responses to the consultation was also published.

The Plan gives further detail on Scottish Government actions, such as announcing a First National Assessment of Potential Heat Network Zones, which will be published shortly. It also sets out future consultation details for the different sets of regulations identified in the Heat Networks Act.

Responding, Helen said: "We welcome the publication of The Scottish Government's Heat Networks Delivery Plan in which it sets out how it is going to meet very ambitious targets of 2.6TWh of output by 2027 and 6TWh by 2030 - 3% and 8% respectively of current heat supply."
