Dear member,

You will be aware of media reports suggesting renewable electricity generators could be liable to pay a windfall tax imposed on companies which have benefitted from recent high wholesale prices.

Scottish Renewables acted quickly on this issue, speaking with HM Treasury and drafting a letter to Chancellor Rishi Sunak which was later co-signed by RenewableUK, Energy UK and the Nuclear Industry Association.



That letter set out the danger of rapid policy change on the investment climate as well as the benefits renewables are providing as a buffer against high gas prices.

While the imminent threat of a windfall tax has now lessened. we continue to act on this issue and will keep members informed as the Treasury lets us know of any next steps.

SR Final Response: The future for National Parks in Scotland

The current Programme for Government contains a commitment to establish at least one new National Park in Scotland by Spring 2026. To do this The Scottish Government launched a Challenge for Ideas to assess any area which is put forward for designation against a set of agreed expectations for what National Parks will deliver for Scotland going forward.

Scottish Renewables has submitted a response to The Scottish Government's Challenge for Ideas Q4. What criteria should we use to decide where the next new National Parks in Scotland should be? SR's online response recommends only areas which fall within existing National Scenic Areas should be considered.

Following the closing of the Dialogue Challenge on June 6, all responses will be collated and analysed. The information gathered will form the basis of face-to-face stakeholder engagement led by NatureScot, supported by a consultation.

News release: £106 million wind power rates windfall revealed

We recently released new figures which reveal that more than £106 million a year in business rates payments flows into Scotland's economy - enough to educate almost 14,000 secondary school children or build more than 750 council houses.

Claire Mack, Chief Executive of Scottish Renewables, said: "Onshore wind is the backbone of Scotland's electricity system, producing the equivalent of 60.2% of our electricity demand and employing almost 9,000 people.

"These new figures show just one part of the onshore wind industry's contribution to Scotland's economy - but one which is hidden from public view and often overlooked when the benefits of these developments are discussed."

Police Scotland and abnormal loads issue

Scottish Renewables, in collaboration with RenewableUK, facilitated a productive practitioners meeting between Police Scotland, The Scottish Government, hauliers and members to discuss the current position with movement scheduling and ongoing work.

SR attended a further stakeholder meeting on behalf of members on May 23, with the focus on situational updates, concerns and actions. SR is continuing to work closely with our members, RUK, hauliers and The Scottish Government to liaise with Police Scotland to find solutions to this issue.



Eskdalemuir Working Group Meeting Minutes

In that response, which appeared in an edited form in the final report in The Herald, we said: "... to focus on [community benefit payments] when the prize is so much larger, more farreaching and longer-lasting would be doing a disservice to an industry which is about to transform the fortunes of Scotland's coastal communities forever".

£160 million funding for floating wind manufacturing

The UK Government has announced a £160 million fund to boost floating offshore wind capability around the UK and support the ambition announced in the British Energy Security Strategy to deliver up to 50GW of offshore wind by 2030, including up to 5GW of floating wind.

BEIS is now requesting information to understand the risks, constraints and opportunities available in the UK and how this capital investment can be most effectively used. The information gathered will be used to inform the feasibility and the design of the funding, as well as wider offshore wind policy.

Launch of the Scottish Marine Environmental **Enhancement Fund**

A ground-breaking green finance initiative has been launched with the aim of transforming the health of Scotland's coasts & seas. The Scottish Marine Environmental Enhancement Fund (SMEEF) has received £500,000 from The Scottish Government's Nature Restoration Fund to begin this vital work.

The fund, administered by NatureScot, accepts voluntary donations from a range of marine users and has been supported by a number of our members. It will award grants to marine environmental enhancement projects to ensure that our coasts and seas are healthy, productive and rich in nature.

ESO Net Zero Market Reform - report published

NGESO published the outcomes of the Net Zero Market Reform project. In summary, NGESO is proposing to change the current single national price market to a Locational Marginal Pricing (LMP), also known as nodal pricing. They are specifically proposing the implementation of LMP combined with a central dispatch model with self-commitment and believe it would be implementable within five years.

BEIS and Ofgem has published its response to the Future System Operator (FSO) consultation. Government and Ofgem are committing to proceed with the creation of a new, independent FSO, which is expected to be a public corporation. The FSO will have a statutory advisory duty to provide expert advice, analysis and information to Ofgem and government.

This is great news as we advocated in our consultation <u>response</u> for the creation of an independent and public FSO, with enhanced roles and a statutory advisory duty in line with our transition to net-zero.

Scottish Renewables visit to AMIDS district heating site in Renfrewshire

Nick and Helen had a fascinating visit to the AMIDS (Advanced Manufacturing Innovation District Scotland) site in Renfrewshire with Scottish Renewables member FES Group to see the construction of its district heat network. The wastewater from a Scottish Water treatment site is directed to an energy centre where heat is extracted then distributed through pipes.

The heat network will warm the new National Manufacturing Institute Scotland and UK CPI buildings. This collaborative project is funded by Renfrewshire Council and The Scottish Government's Low Carbon Infrastructure Transition Programme.



A market-based mechanism for low-carbon heat

The UK Government published its <u>response</u> to a consultation which planned to increase the amount of heat pumps by creating a market incentive to grow the number of heat pumps installed in existing buildings each year. SR had submitted a letter in response to this consultation.

Government plans to take forward the lead option in the consultation, which places an obligation on manufacturers of fossil fuel heating appliances. This obligation will be focused on hydronic (air-to-water) heat pumps and will be based upon a rising standard for the number of heat pump sales to endconsumers as a proportion of a firm's fossil fuel boiler sales. The UK Government intends to focus the scheme on retrofit installations of hydronic heat pumps under 45kWth, including in smaller non-domestic buildings where such 'domestic-scale' appliances are appropriate.

There will be a further consultation soon on a more detailed design of the mechanism.
