SR consultation response: proposed changes to application fees

SR has submitted a final response to The Scottish Government and Energy Consents Unit's consultation on proposed changes to application fees charged for applications submitted under sections 36, 36C and 37 of the Electricity Act 1989.

Our response supports the principle of proportionate cost recovery to create a well-resourced energy consenting regime that can efficiently respond to the challenges of decarbonisation and net-zero. However, in responding SR requested that further information be provided to explain the magnitude of increases proposed before any changes to fee structures are implemented.

Related, The Scottish Government has published Circular 2/2022 on planning fees which provides guidance on provisions within the Town and Country Planning (fees for Applications) Regulations as amended. This circular replaces 1/2004 and 2/2013.



SR consultation response: draft guidance for solar farms

SR has submitted a <u>final response</u> to NatureScot's draft guidance on general pre-application and scoping advice for solar farms. The new draft guidance will replace NatureScot's existing solar guidance. Our recommendation is a redraft of

this guidance which starts from the point of view that solar is a relatively benign form of development which brings with it opportunities for Scotland to enhance biodiversity, reduce flood risk and enhance our landscapes.

Guidance for applicants on using the design envelope for applications

The Energy Consents Unit and Marine Scotland published on June 6, guidance for applicants on using the design envelope approach for applications under section 36 of the Electricity Act 1989, where flexibility is required in applications.

The guidance explains how the design envelope assessment approach may be applied in applications and also provides background to the relevant case law and environmental impact assessment practice that has developed in this area.



ONSHORE RENEWABLES



Onshore Wind Vision and Sector Deal for Scotland

Scottish Renewables is leading a conversation between the renewable energy industry and The Scottish Government in relation to the establishment of a Vision and Sector Deal for onshore wind for Scotland.

The Vision and Sector Deal would seek to capture the needs and ambitions of The Scottish Government and the Scottish wind industry to act as an enabling tool for delivering an additional 12GW of onshore wind capacity in Scotland by 2030.

SR has held a series of exploratory discussions with BVG Associates and The Scottish Government on how to develop the onshore Vision and Sector Deal over the next 12 months.

Police Scotland and abnormal loads issue

Scottish Renewables, in collaboration with RenewableUK, is engaging with The Scottish Government and Police Scotland on behalf of members to form a legislative reform sub-group. The sub-group will consider which other aspects of the renewables industry would benefit from legislative change (transportation of hydrogen for example) and to undertake a cost-benefit analysis, among other matters.

Despite a temporary resurgence of Covid absences, abnormal load escorts have been progressing mostly positively with some green shoots around weekend movements in some areas. SR is continuing to work closely with our members, RUK, hauliers and The Scottish Government to liaise with Police Scotland to find solutions to this issue to ensure the movements continue to take place timely and safely.

Blog: Putting a value on Scotland's offshore wind revolution

Everyone in renewables should know by now that Scotland's energy landscape will be transformed by ScotWind.

The numbers are huge: 17 offshore wind projects, 25GW, up to £24.9 billion of planned investment into the Scottish economy.

In our latest blog we have crunched the numbers and created easily-accessible graphics to give an inside look at what ScotWind could mean for our offshore wind supply chain.

Media reaction: UK Offshore Wind Skills Intelligence Report

The Offshore Wind Industry Council recently published a new report which shows a surge in the number of people working in the UK offshore wind industry, and a substantial increase in the billions of pounds of private investment which the sector is attracting every year.

Responding, Charlotte Stamper, Senior Policy Manager at Scottish Renewables, said: "The benefits to Scottish communities which stem from this will be transformational: projects which were recently awarded seabed leases have committed to invest in Scotland – and specifically in supply chain businesses - on a scale never seen before, in any industry. This investment will deliver tens of thousands of skilled jobs, allow Scottish firms to compete in the global offshore wind market and revitalise communities from the Borders to the islands."

Offshore wind consenting

SR's Offshore Enabling Group continues to meet regularly to coordinate action to address environmental constraints affecting the deployment of offshore wind in Scottish waters. We are seeing positive engagement with consenting authorities and are working with the Offshore Wind Industry Council to ensure Scottish interests are represented at a UK level.

BEIS consultation on updating the CfD AR5 **Supply Chain Plan questionnaire**

SR has <u>submitted a final response</u> to BEIS' consultation on updating the CfD AR5 Supply Chain Plan questionnaire.

Our response welcomed the increased clarity and simplicity that the proposed amendments brought in certain areas. However, we suggested that particular information could be collected via a separate channel in order to streamline the SCP process ahead of the move to annual auctions. We also voiced our concern that the bespoke questionnaire placed unrealistic expectations on small floating offshore wind projects to deliver supply chain investment and that the focus of the questionnaire should instead be to incentivise innovation and the delivery of new technology.



GRID & SYSTEMS



Scottish Renewables Response to the TNUoS Task Force Update

Scottish Renewables wrote a letter to Ofgem to raise concerns regarding the terms of reference published on the TNUoS Task Force document. The main concerns were around the long timeline to develop the task force (between 5-7 years), the exclusion of TNUoS function in a net-zero decentralised energy system, and the limited seats for renewable generators.

Call for Input on Locational Pricing Assessment – Policy Advisory Group meeting

Scottish Renewables held a Policy Advisory Group (PAG) meeting on June 15 to shape the SR response to the call for input from Ofgem on locational pricing. The meeting focused on the challenges that Locational Marginal Pricing (LMP) could add to the energy system and the key factors that Ofgem should consider in the modelling.

Consultation on Ofgem's Minded-to Decision on Anticipatory Investment and Implementation of Policy Changes

Scottish Renewables submitted a response to the Consultation on Anticipatory Investment and Implementation of Policy Changes. In the response, we strongly supported the need to enable anticipatory investment (AI), with a model of risk-sharing between consumers and generators, but we required greater clarity regarding how later users delivered at different stages will pay for the AI cost gap.

LOW-CARBON HEAT



Building Standards and Heat Networks issue

We had highlighted to the Low-Carbon Heat Forum that there is an issue with the amended section 6 of the Scottish Building Standards potentially disincentivising heat networks.

There are two issues at play here. The first is that the same energy values are being used for setting both the target and the actual building. This means that the net impact of the district heat network is zero, so by connecting to a district heat network the building developer gets no benefit over the nominal building specification.

The second issue is that when you supply heat from a district heat network the target building has its energy consumption reduced by the inclusion of solar PV in the design. This means that the building designer needs to find energy savings in their building specification from something other than the district heat network to achieve this lower specification.

We contacted both the Heat Networks Team and the Building Standards Division of The Scottish Government and have had a reply from Building Standards setting out a way forward to speak further on this issue.

We will keep the Low-Carbon Heat Forum updated as to the eventual outcome, so please ensure you are signed up to that Forum if you are interested.



Heat Networks (Scotland) Act work packages

We attended a Scottish Government Heat Networks Working Group meeting which set out the four work packages of regulations and consultations that will be forthcoming from the Heat Networks (Scotland) Act 2021.

The work packages and timeframes of work starting are:

- Work Package 1: Building Assessment Reports and Heat Network Zoning (work beginning imminently)
- Work Package 2: Consenting and Key Network Assets (work beginning by the end of the summer)
- Work Package 3: Permitting and the Local Authority Cost Strategy (work beginning in autumn 2022)
- · Work Package 4: Licensing and Powers of Licence Holders (work beginning in winter 2022/23)

Scottish Renewables has a Policy Working Group on Heat Networks which will discuss these issues and we will create short-life Policy Advisory Groups for the specific consultations.

Heat Pumps update

We are waiting for the The Scottish Government response to the <u>final report</u> of the Heat Pump Sector Deal Expert Advisory Group, which SR was a member of.

The response will be published alongside the Heat in Buildings Supply Chain Delivery Plan which is due in September 2022.

Also expected to be published soon is The Scottish Government's Heat in Buildings Workforce Assessment which was looking at heat skills and the supply chain along with SR and Skills Development Scotland.



Financing Green Heat Policy Working Group

The PWG recently had its second meeting with a guest speaking slot from The Scottish Government's Green Heat Finance Taskforce Secretariat. Issues discussed included the challenges and barriers encountered by members in the market regarding renewable heat projects. Members highlighted EPC reform, issues with SAP, high transmission costs, Heat as a Service being unproven, communal heating in social housing, Local Heat and Energy Efficiency Strategies and behavioural aspects.

Hydrogen Innovation Scheme funding

The Scottish Government announced new funding to drive innovation within the hydrogen sector and accelerate its production and storage. The Hydrogen Innovation Scheme is a £10 million capital funding stream of the Emerging Energy Technologies Fund, to be delivered over 4 years from 2022/23 -2025/26.

Responding, Helen Melone, Senior Policy Manager at Scottish Renewables, said: "Hydrogen will play a key role in our transition to the net-zero energy system we need to build to tackle climate change, and support for its production and integration into our energy system is to be welcomed."

The Scottish Government has published the guidance and an expression of interest form for the scheme on its website.

The deadline for submission is August 13 at 5pm. Expressions of interest submitted after this deadline may still be considered but are not guaranteed to be included within the 22/23 funding window.
